Application Guideline for Undergraduate Entrance Examination (Overseas Entrance Examination)

1. Application Outline

The Undergraduate International Students Entrance Examination will be admitting applicants after a comprehensive screening of their essay, interview, Japanese language proficiency score, and other application documents. Applicants can take the entrance examination from their home country and may be admitted to enter the university.

2. Number of Enrollments

Faculty of Economics

- Department of Economics and Management: a few
- Department of Global Culture Industry & Tourism: a few

3. Period of Study

4 years

4. Qualifications

Applicants must meet the following (1)~(3)

- (1) Those who have completed, or are expected to complete, 12 years of formal education in foreign countries and hold qualification to enter university, or those who holds equivalent qualification.
- (2) Those who hold Japanese language proficiency of N2 of the Japanese-Language Proficiency Test or C level or above of J.TEST (Test of Practical Japanese) and have or are expected to studied Japanese for 600 hours or more.
- (3) Those who are recognized individually by the university as having qualifications equivalent to (1) and (2) above.

Those who are residing in Japan and hold qualifications mentioned above are not eligible to take this entrance examination.

Application Guideline for Undergraduate Transfer Entrance Examination (Overseas Entrance Examination)

1. Application Outline

The Undergraduate Transfer/International Entrance Examination will be admitting applicants after a comprehensive screening of their essay, interview, Japanese language proficiency score, and other application documents. Applicants can take the entrance examination from their home country and may be admitted to enter the university.

- Department of Global Culture Industry & Tourism: a few

3. Academic Year of Transfer

3rd year

4. Period of Study

2 years

5. Qualifications

Applicants must meet the following (1)~(3)

- (1) Those who completed or are expected to complete by September 2025 a two-year course at a university outside Japan.
- (2) Those who have Japanese language proficiency of N2 of the Japanese Language Proficiency Test (Japan Educational Exchanges and Services Foundation/Japan Educational Exchanges and Services) or C level or above of J.TEST (Practical Japanese Test) and have or are expected to studied Japanese for 600 hours or more.
- (3) Those who have reached a reasonable age and are recognized by the university as having qualifications equivalent to (1) and (2) above.

※ Those who are residing in Japan and hold qualifications mentioned above are not eligible to take this entrance examination.

※ Those who have completed their two-year course at a university may not be able to graduate within two years after transferring, depending on the number of credits earned.

3. Qualifications

- (1) Those who have completed, or are expected to complete, 12 years of formal education in foreign countries and hold qualification to enter university, or those who holds equivalent qualification.
- (2) Those who hold Japanese language proficiency of N5 of the Japanese Language Proficiency Test (Japan Educational Exchanges and Services Foundation/Japan Educational Exchanges and Services) or Level F of the J.TEST (Practical Japanese Test) or Level 5 or higher of the NAT-TEST (Nippon Association for Teaching Specialized Education).
- (3) Those who are recognized individually by the university as having qualifications equivalent to (1) and (2) above. However, in the case of substituting Japanese study hours for (2), applicants must be able to demonstrate English proficiency in TOEFL (iBT), TOEIC, or IELTS to the extent that it does not interfere with their academic life.

※ For applicants residing in Japan with the above application qualifications

- ① Applicants must already have a visa such as “Student visa,” “Family Resident visa,” “Spouse visa,” “Permanent Resident card,” or “Settled Resident visa.” Visas for “Temporary Visitor,” “Trainee,” “Entertainer,” etc. will not be accepted.
- ② “Student visa” holders must have entered school in April 1, 2024 or later.
- ③ Japanese language school students must have permission from the school to transfer to another school.
- ④ For “Student visa” , applicants must be enrolled in a preparatory course at a Japanese language school or a Japanese language course at a vocational school. Students enrolled in a university undergraduate school or a special course for international students are not eligible to apply.

- (4) In principle, must be students who wish to enter Kobe International University.

There will be a penalty of 150,000 yen if the contract is terminated in the middle of the contract period. If you wish to change the type of dormitory, there may be an additional charge.

※ In addition, about 30,000 yen for textbooks, medical checkup and Japanese language examination fee and about 5,000 yen for Automobile insurance fee for those who wish to commute by bicycle.

※ Once received, the school fee, dormitory fees, and other expenses are non-refundable in any reason, except in the case of ③ and ④ on page 9, section 2.

※ Those who have completed the Japanese Language Program (Kokusai Bekka) and have been recommended by the head of its program and have passed the entrance examination student may enter Kobe International University. Those who enter Kobe International University are exempted from taking the Examination for Japanese University Admission for International Students (EJU) and receive a 30% tuition reduction for the first year. In addition, only those who pass the Special Recommendation Entrance Examination for Japanese Language Program (Kokusai Bekka) (1st round) will be exempted from paying the full amount of the entrance fee at the time of university admission.



【Documents for the applicant】

- 1) Application form for admission (Form B prescribed by the university)
- 2) Letter of Reason for Studying Abroad (Form C)
- 3) Diploma (from high school or later)
- 4) Score report of Japanese Language Proficiency Test (JLPT, J.TEST, NAT-TEST), etc.
- 5) Certificate of hours of Japanese language study (only for applicants who have not passed the JLPT and who wish to study in a school other than the Japanese Language Program (Kokusai Bekka))
- 6) Score sheet of TOEFL(iBT) or other English proficiency tests (Only for applicants who have not passed the JLPT or J.TEST as proof of Japanese language proficiency)
- 7) Photo (4cm x 3cm) taken within the last 6 months (write your family name and date of birth on the back)
- 8) A4 color copy of passport (page with photo, page with all stamps if the applicant has immigration history)
- 9) A4 color copy of ID (both sides)
- 10) Certificate of Health Examination (Form D prescribed by the University)

【Documents related to the financial supporter】

- 11) Letter of Reimbursement (Form E designated by the University)
- 12) A4 color copy of ID (both sides)
- 13) Certificate of employment
- 14) Certificate of tax payment and proof of income (3 years' worth of the sponsor's own documents, including the annual income of 120,000 yuan in Mainland China) If the annual income in Mainland China is 120,000 RMB or more, a personal income tax payment record (proof of tax payment) issued by the taxation bureau is required.)
- 15) Bank balance certificate
- 16) Documents proving the applicant's kinship with the applicant

※Each certificate must be submitted on a form with the applicant's address and telephone number, and a translation must be attached. (A4 size)

※Other additional documents may be requested.

※Please make sure that all documents are filled out correctly so that there are no Blank Space. If there is no entry, please draw a shaded “/” line.

※Please be sure to use documents with a “Letter Head” for certification of each institution such as schools.

Documents and materials once accepted will not be returned.

※If there are any false items in the submitted application documents, or if they do not meet the screening standards of the University, the applicant will be immediately rejected. If it is discovered after admission, the applicant will be expelled from the university.

2. Admission Procedures

- ① After the “Certificate of Eligibility (College Student)” is issued, please pay the admission fee, tuition and other fees. All fees for remittance of the enrollment fee are to be paid by the applicant. Once the University confirms the payment, the “Certificate of Eligibility (College Student),” “Letter of Admission,” and the submitted “Certificate of Graduation” will be sent to the applicant. The student must apply for a visa at the Japanese Embassy or Consulate-General in their home country.
- ② If the applicant declines to enter the school or receives a “Certificate of Eligibility Not Granted” from the Immigration Bureau, they will not be able to obtain a visa and their acceptance will be automatically cancelled.
- ③ Of the school fees paid (entrance fee, tuition, facility expansion fee, equipment maintenance fee, and comission), only the amount excluding the entrance fee will be refunded if the student declines admission or the visa is not issued by September 30, 2025, after the Certificate of Eligibility is issued. After October 1, 2025, there will be no refunds of any school fees.
- ④ Of the dormitory fees (entrance fee, security deposit, and dormitory expenses) once paid, only the dorm entrance fee and the dormitory expenses excluding the penalty fee (allocated from the security deposit) will be refunded if the applicant declines admission or fails to receive a visa by September 17, 2025, and after September 18, 2025, no refund will be made for the entrance fee, the penalty fee (allocated from the security deposit), and the dormitory fee until the last day of the month following the cancellation date.
